- vii) Land will be used for the purpose strictly for the purpose it was originally allotted;
- viii) Provision of RTE Act and the guidelines issued by the U.T, Administration/CBSE from time to time will be complied with by the school authority in letter and spirit;
- ix) Matter can be reviewed by the Department in case of violation of terms and conditions.
- x) Teacher recruited for the purpose must possess the latest required qualification per norms.
- xi) Reserve Fund required as per the Education Code must maintain.
- xii) Managing Committee of the school must got approved from the Education Department as per Education code norms.
- xiii) Security is being charged from the students which should be refunded online in the accounts of students after following proper procedure.
- xiv) The Minimum strength required as per the CBSE norms must be maintained in each class/section.
